## Synova backs Stackhouse Poland MBO

Synova Capital LLP ("Synova"), a leading investor in UK growth companies, is pleased to announce that it has supported the management buyout of **Stackhouse Poland Holdings Limited** ("Stackhouse Poland" or the "Company"), one of the UK's top 15 independent insurance brokers. The Company specialises in private client and niche commercial advisory and broking business with a focus on high net worth individuals ("HNW").

Stackhouse Poland has built its strong reputation around tailoring insurance solutions for its high net worth private clients and companies with specific commercial insurance requirements. I do believe we are now ready for the next chapter."

Alex Bowden, a Partner of Synova and Director of Stackhouse Poland added: "Synova has developed a particular focus on businesses providing niche services into the Financial Services sector; we identified and initially contacted Stackhouse Poland nearly three years' ago and have since built a strong relationship with the management team. Over that time they have built a powerful offering in the increasingly complex HNW led private client and specialist commercial lines markets, as well as completing a series of highly accretive acquisitions in what remains a highly fragmented sector. We are delighted to be partnering with Jeremy, James and Tim as they and their team build the pre-eminent private client and specialist commercial lines focused broker."
